MEMORANDUM OF UNDERSTANDING

Itasca Community College
and
Mayville State University

INTRODUCTION

This Memorandum of Understanding (MOU) formally recognizes that Itasca Community College (ICC) and Mayville State University (MSU) are active educational partners, committed to providing greater educational opportunities and services for students transferring between institutions. This commitment strongly supports the concept of seamless transfer that embraces the principle that transfer students should not be required to repeat competencies already achieved.

• ICC and MSU enter into this MOU in the spirit of cooperation and mutually recognize each other as quality institutions of higher learning. Each institution, furthermore, is dedicated to serving students from all walks of life, regardless of race, ethnicity, religion, sex, disability, color, age, marital status, national origin or other non-merit factors.

STATEMENT OF PURPOSE

The purpose of this agreement is to provide a smooth transition for transferring from one related degree program to another. It is further recognized that the attached agreement describes how courses will transfer from ICC to MSU. This agreement identifies all required and equivalent courses at each institution for:

Early Childhood (BA)
Early Childhood Education (BSEd)
General Education

TERMS AND CONDITIONS OF CREDIT TRANSFER

Students transferring from Itasca Community College must meet the admission requirements of Mayville State University. The evaluation and transfer of earned college credits shall be in full compliance with North Dakota State Board of Higher Education policies and North Dakota University System Academic Affairs Council guidelines and all other State and Federal education policies pertaining to undergraduate credit transfer. Current students and graduates who have earned degrees from ICC shall be eligible for credit evaluation under the terms of this agreement.

GENERAL UNDERSTANDINGS

ICC and MSU agree to provide direct links between their institutional websites indicating the existence of this transfer agreement. Official lists of programs for which articulation agreements have been approved by both ICC and MSU will be made available at both institutions and on their corresponding websites.

ICC and MSU agree to exchange data and documents that will contribute to the maintenance and improvement of these transfer agreements, and that will promote effective cooperation between the two institutions.

ARTICULATION IMPLEMENTATION AND AGREEMENT REVIEW

The President or designee of the collaborating institutions shall be responsible for implementing this agreement and for identifying and incorporating any changes into subsequent agreements, and for conducting a periodic review of this agreement.

This MOU is in perpetuity or until it is discontinued by either educational partner by submitting written notification to the other partner one year prior to the identified cancellation date in order to protect all students transferring between these institutions.

MINNESOTA STATE COLLEGES AND UNIVERSITIES* ARTICULATION AGREEMENT BETWEEN

ITASCA COMMUNITY COLLEGE AND MAYVILLE STATE UNIVERSITY

*The Board of Trustees of the Minnesota State Colleges and Universities is authorized by Minnesota Statutes, Chapter 136F to enter into Agreements and has delegated this authority to colleges and universities.

This Agreement is entered into between ITASCA COMMUNITY COLLEGE (hereinafter sending institution), and MAYVILLE STATE UNIVERSITY (hereinafter receiving institution). This Agreement and any amendments and supplements, shall be interpreted pursuant to the laws of the State of Minnesota.

The sending institution has established an Associate in Science Degree in Early Childhood (hereinafter sending program), and the receiving institution has established a Bachelor of Arts Degree in Early Childhood (hereinafter receiving program), and will facilitate credit transfer and provide a smooth transition from one related program to another. It is mutually agreed:

Admission and Graduation Requirements

- A. The receiving institution's admission and program admission requirements apply to both direct entry students and to students who transfer under this agreement.
- B. Students must fulfill the graduation requirements at both institutions.
- C. Students must complete the entire sending program and meet the receiving institution's admission requirements for the agreement to apply.

Transfer of Credits

- A. The receiving institution will accept 60 credits from the sending program. A total of 65 credits remain to complete the receiving program.
- B. Courses will transfer as described in the attached Program Articulation Table. For system institutions, once the courses are encoded, they will transfer as described in the uSelect Audit.

Implementation and Review

- A. The Chief Academic Officers or designees of the parties to this agreement will implement the terms of this agreement, including identifying and incorporating any changes into subsequent agreements, assuring compliance with system policy, procedure and guidelines, and conducting a periodic review of this agreement.
- B. This Articulation Agreement is effective on 06/26/2013 and shall remain in effect until the end date of 06/25/2018 or for five years, whichever occurs first, unless terminated or amended by either party with 90 days prior written notice.
- C. The college and university shall work with students to resolve the transfer of courses should changes to either program occur while the agreement is in effect.
- D. This Articulation Agreement will be reviewed by both parties beginning 12/25/2017 (within six months of the end date).
- E. When a student notifies the receiving institution of their intent to follow this agreement, the receiving institution will encode course waivers and substitutions.

Instructions

The ECED 2202 Pre-School Internship course will automatically transfer in for the EC 376 Field Experience in ECE course. Students who wish to also receive transfer credit for the ECED 2202 Pre-School Internship for the MSU EC 375 course must meet the following requirements:

- 1. The student will be in a supervised tutorial or apprenticeship-type experience in an approved early childhood setting. Students should have the opportunity to develop and expand skills in their chosen specialty areas (Infant/toddler or special needs).
- 2. The experience should be in a Licensed child care program (group or center based, Head Start).
- 3. Under supervision of a teacher with at least an AA degree specifically in ECE.
- 4. Minimum of 45 documented hours with children in the specialization (infant toddler or special needs).
- 5. Minimum of 6 documented developmentally appropriate lesson plans or activity plans specific to the specialization (address a variety of domains--social, emotional, cognitive, physical; and a variety of areas--music, sensory, books, creative art, etc.) carried out with children and then evaluated/reflected on by student.
- 6. Letter of recommendation from the supervising teacher.

GRADUATION REQUIREMENTS:

- 1. Completion of 120 semester credits is required for a four-year degree of which at least 36 semester credits must be in the upper-division courses (300-400 level).
- 2. A degree is granted only to students who have enrolled at Mayville State University for at least two consecutive semesters and who have earned at least 30 semester credits through Mayville State University.
- 3. Candidates for the degree must be enrolled at Mayville State University during the semester in which the degree is conferred.
- 4. Candidates must have a grade point average (GPA) of at least 2.00 for the general overall average, all credits applied to a degree program, and for all courses attempted at Mayville State University.
- 5. Candidates must complete all the general education course requirements with a GPA of at least 2.00.
- 6. Candidates must complete 36 hours at the 300-400 level.
