The FAFSA Simplification Act changes eligibility for what were formerly called Iraq and Afghanistan Service Grants (IASG) and Children of Fallen Heroes (CFH) Awards as well as the resulting award amount.

- 1. Serving on active duty as a member of the armed forces on or after September 11, 2001, or
2. Performing official duties as a public safety officer:
- A Public safety officer generally includes the following:
i. Law enforcement officer, firefighter, or chaplain,
ii. Federal Emergency Management Agency (FEMA) employee,
iii. Emergency management or civil defense agency employee,
iv. Member of a rescue squad of ambulance crew, or
v. Others as defined in the Omnibus Crime Control and Safe Streets Act of 1968.

Is your answer to the above question, correct?

Written letter of attestation or determination made by a state or local government official with supervisory or other relevant oversight authority of an individual who died in the line of duty while serving as a public safety officer; or
Documentation of the student qualifying for a state tuition or other state benefit accorded to the children or other family members of a public safety officer consistent with the definition in 42U.S.C. 3796b, or as a fire police officer; or
Other documentation from a credible source that describes or reports the circumstances of the death and the occupation of the parent or guardian.
