Course Description

Moving from the Renaissance through the collapse of Communism, Europe's impact upon the world alongside unique developments in Africa, the Americas, and Asia, are evaluated in terms of attempts to retain their traditional cultural identity in light of wars, new technologies, scientific discoveries, and intense interactions with foreign cultures. Pre-/Co-requisites: No Pre-/Co-requisites are required.

Course Objectives

A quality work:

The central ideas are well developed, and exhibited throughout the paper is clarity of purpose. The evidence used shows critical, careful thought and analysis of the source material. The concentration of the paper is focused.

B quality work:

The central ideas and clarity of purpose are generally evident in the assignment, but not 100% crystal clear. The evidence used shows a high level of critical, careful thought and analysis of the source material, but there is more room for details. The concentration of the paper is good, but could be better focused.

C quality work:

The central ideas and clarity of purpose are vague and lack detail. The evidence used shows a mediocre level of critical, careful thought and analysis of the source material, and there is significantly more room for details. The concentration of the paper is sufficient, but needs to be better focused.

D quality work:

The central ideas and clarity of purpose are vague and difficult to find. The evidence used shows little to no critical, careful thought, and the analysis of the source material is poor. There is profoundly more room for detail. The concentration of the paper is substandard, and has little to no focus.

F quality work:

The work fails to have any clarity of purpose, no evidence used, no critical thought, and a massive amount of detail is missing.
