DAY 2 SUNDAY, JULY 12

DAY 7 FRIDAY, JULY 17

Dublin: Discover central Dublin with a local guide. Cross the bridge to Valentia Island to visit the Skellig Experience, which explains the life of early Christian hermits on Skellig Michael, a rocky offshore island featured in the film "Star Wars VII." Enjoy a casual lunch and later stop in the pretty village of Sneem. Pause at Moll's Gap for panoramic mountain views and return to Killarney where the evening is free. Overnight at hotel.

DAY 10 MONDAY, JULY 20

[B,D] Killarney-Bunratty: Take in the enormity of the Cliffs of Moher, a spectacular wall of sandstone that reaches 700 feet above the Atlantic. Walk along the Cliffs for stunning views.
